Patient crochets a “mountain of blankets”

Patricia Powell, 78, loves to crochet. She’s been at it for 50 years. Her family calculates that she has more than 300 blankets in storage right now, blankets she plans to donate to Coastal Hospice, which will distribute them to other patients to keep them warm and covered with love.

“There’s a mountain of blankets,” said Patricia’s great granddaughter, Paige White, who is also her caregiver.

Patricia, who was twice widowed, is herself surrounded by love in a Parsonsburg home she shares with several generations of family. She has been under hospice care since June 2016.

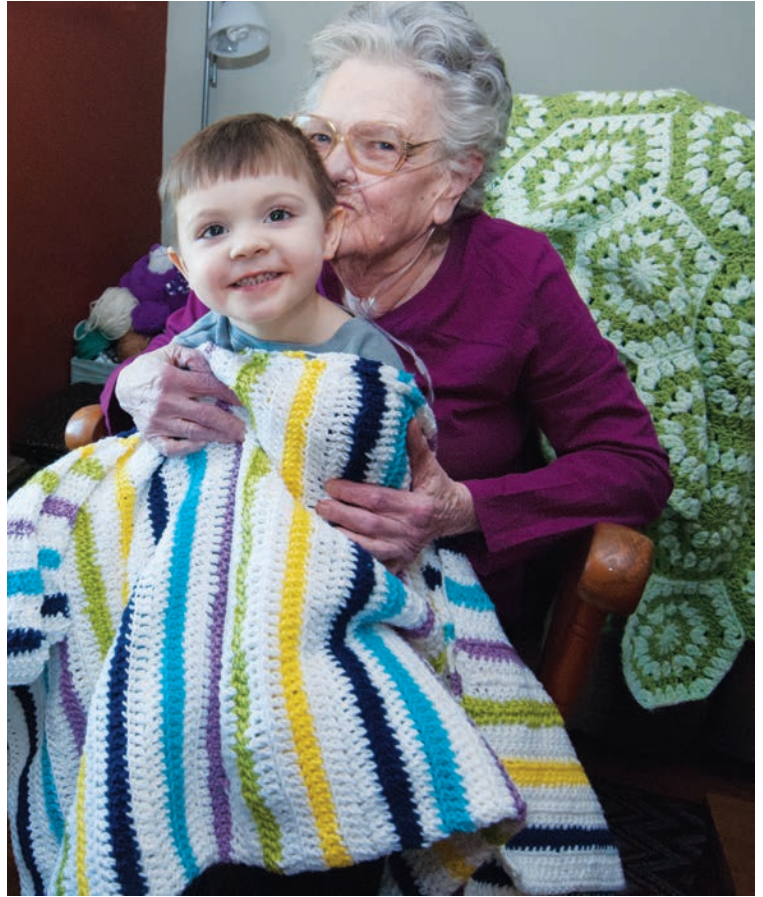
“She’s a sweetheart,” Patricia said of her hospice nurse, Cheryl Fisher, who visits every Thursday. “We just seem to be compatible. Hospice makes it easier.”

Earlier in her life, Patricia battled cancer twice but both times came out on top. Last spring, she was feeling ill and diagnosed with stage 3 lung cancer. She and her family decided hospice was their best option. It was a hard decision for them.

“At first, when I thought of hospice, it was just for people who didn’t have very long, so we were against it,” Paige said. “Then we realized she could be with hospice for years, so we decided to give them a call. And it’s been great. She hasn’t had to go to the doctor. (Nurse) Cheryl takes care of what she needs. Or (Coastal Hospice physician) Dr. Nicholas Borodulia comes to visit.”

Construction to begin soon on Coastal Hospice at the Ocean

We have some very good news to share: Thanks to your generous support, we now own the building that will become Coastal Hospice at the Ocean. The Board has approved the renovation design and the contractor, Whiting-Turner will soon have a team assembled to begin work.

Coastal Hospice at the Ocean will be a hospice residence, which is something new for this community. Most of our patients are cared for in their homes, some in nursing homes or assisted living centers. Patients at Coastal Hospice at the Lake need and receive a more intensive level of care to manage their symptoms, and usually stay just a few days.

For those who need around-the-clock support but who don’t have an able caregiver living with them, we are creating Coastal Hospice at the Ocean. There, they can spend their final weeks in safety, with dignity and qualified care.

Our staff and area care coordinators first told us about the need for a hospice residence a few years ago. The Coastal Hospice Board commissioned a Bed Needs Assessment that reported

Q: Does early hospice care mean a better quality of life for patients?

A: According to a recent study, published in the Journal of Clinical Oncology, it does.

Hospice was associated with better symptom relief, attainment of pain-management goals, and quality of end-of-life care, the study found. The researchers interviewed families of terminally ill cancer patients after their loved one had passed. They learned that family members may be more satisfied with the end-of-life treatment their loved ones receive when it involves hospice care. Families of patients who received at least 30 days of hospice care reported the highest quality of life outcomes.

Many people think of hospice as something that should be saved for the very end of life, said study co-author Dr. Alexi Wright of Harvard Medical School and Dana-Farber Cancer Institute in Boston.

“However, our findings suggest that earlier hospice enrollment is associated with better symptom management, less pain, better quality of care, and a higher likelihood that patients will receive the care that they want in their own environment,” Wright said.

Patients with advanced cancer often experience pain, difficulty breathing and distress at the end of life and frequently use intensive, hospital-based care during their final days, researchers noted. Hospice offers an alternative approach, focused on comfort, and often delivers care within a home environment that many families may prefer. About 80 percent of families whose loved one had received hospice care reported the amount of pain medicine was just right; 78 percent said the patient got the right amount of relief from breathing difficulties; 80 percent said patients’ end-of-life wishes were followed.

The results add to a growing body of evidence linking hospice to better quality of life for patients, a greater likelihood of dying in the location of choice, and less grief-related distress for caregivers.

Enrollment in hospice for more than 30 days is associated with better quality of care at the end of life.

Those whose loved ones are in the care of Coastal Hospice are surveyed by Medicare, in its Consumer Assessment of Health Providers and Systems. the need for a hospice residence that would accommodate 12 patients at a time. We have been planning and fundraising for this project since then.

Just over a year ago, the Board was presented with the opportunity to buy a large, unfinished building at The Point in Ocean Pines. Nestled on a point of land on the Isle of Wight Bay, it is an ideal location. The Farmers Bank of Willards sold the property to us at deep discount, bringing it within reach of the capital campaign that was already under way.

When construction is complete, in about a year, most patient rooms will have a waterfront view of the Isle of Wight Bay and the Ocean City skyline. Each room is designed to support medical care, yet look and feel like home. Loved ones will be able to stay overnight in the patient’s room. The building and grounds are will afford opportunities for quiet reflection, as well as for the celebration of life’s joys.

The community has demonstrated its commitment to Coastal Hospice at the Ocean: So far we have received \$4.8 million in gifts and pledges toward our \$5 million goal. Donations are gratefully accepted and can be made securely at CoastalHospice.org. Just look for the campaign thermometer on the home page.

We will keep you posted on our progress and plans to open Coastal Hospice at the Ocean throughout the year in this newsletter.

and yarn for her crocheting work is Sea Needles in Bethany Beach, a store owned by Dr. Borodulia's wife.

"I could go in there and spend a couple of days," Patricia said. "The patterns! I never saw the like in my life!"

Crocheting is a challenge for Patricia. She's left-handed and most patterns are designed for the right-handed. But it's a challenge she's overcome.

Patricia was born and raised in Delmar, De., and spent her life "working and taking care of kids," she said. For many years, she worked at her parent's restaurant, Johnny's Bonton in Laurel, then was a waitress at several local restaurants, most recently at English's in Salisbury.

"Waitressing is hard. People just don't know," she said.

Today, she's taking it easy, crocheting in the mornings and enjoying the energy her young caregiver family brings to her life.

"The good Lord's been with me," she said.



GRIEF SUPPORT

New grief support groups begin in Crisfield and Salisbury

As part of the services we provide, Coastal Hospice offers grief support and education to families, friends, caregivers and others following the death of a loved one. Our grief support meetings are open to anyone in the community who need help — not only hospice families.

During these meetings, participants often help each other. The meeting can be a time of respite and a safe place to express feelings and talk with others who are experiencing similar losses.

"After you have lost a loved one, you may be asking yourself: 'Why can't I get over it?' You may experience many emotions: anxiety, worry, guilt, loneliness," said Bob Miller, grief support counselor with Coastal Hospice.

"All of these thoughts and feelings are normal. The grieving process has no timetable. But if these emotions are interfering with your life, it may be helpful to seek professional help and support. Our services are designed to help you navigate through grief at your own pace."

A new grief support group now meets every 1st and 3rd Tuesday at 11 a.m. at the Somerset County Library, 100 Collins St., Crisfield.

In Salisbury, group support meetings have moved to the MAC Center at 909 Progress Circle off Snow Hill Road. They are held every 2nd and 4th Friday at 1 p.m., and every 2nd and 4th Monday at 6 p.m.

Salisbury native is new team leader at Coastal Hospice at the Lake

Congratulations to Nancy Hayward, RN, MSN, who has been promoted to the position of team leader at Coastal Hospice at the Lake. Hayward previously worked for two years as a nurse at our inpatient facility.

Coastal Hospice at the Lake — which can care for up to 14 patients at a time — is our inpatient facility located at Deer's Head Hospital in Salisbury. It is designed to give patients short-term care, when they need temporary intensified medical care to treat symptoms that cannot be managed at home. The facility is also used for respite care, when a caregiver at home needs a break.

Hayward's duties will include managing the round-the-clock staff and making sure they have what they need to care for the patients and their families.

"Our goal is to make sure our patients aren't suffering, that they have everything they need to pass peacefully, as close to the way they want as possible," Hayward said. "The family can just be the loved one and have someone else give the care."

Hayward attended Washington High School and Wor-Wic Community College and received her nursing and Master's degree from Soujourner-Douglass College. She worked as a geriatric nurse for eight years before taking on the role of team leader at the Lake.

"I cared for the older generation as a geriatric nurse in nursing homes, watching people passing not as comfortable as they should be," she said. "I'm thankful that I'm with hospice now, because I feel hospice is a great asset to the community, to families and to patients."

Hayward finds personal satisfaction in her new position.

"My personal gratification comes from knowing that we're providing a place where families know their loved ones are going to be safe and comfortable. They don't have to stress," she said.

Two hospice volunteers surprised with prestigious Jefferson Awards

Two long-time Coastal Hospice volunteers are recipients of the 2017 Jefferson Awards. WBOC-TV's Maxine Bentzel presented the awards to the volunteers at surprise ceremonies in December and January, with their stories airing on the station soon after.

Coastal Hospice volunteer Kevin Hughes received his award at a surprise ceremony at his place of employment, Sysco Eastern Maryland LLC in Pocomoke. Hughes has a lifetime of volunteering for his church and community, giving 135 volunteer hours last year to Coastal Hospice alone and thousands of hours since he began volunteering for the non-profit in 2007.

His interest in caring for the sick began when several family members became ill.

"I felt a calling to get involved with the hospice organization," Hughes said. "I knew the public in general has no idea what hospice is all about, so I am able to educate my own family, friends and co-workers about what hospice has to offer."

Hughes is a regular at the hospice's inpatient facility, Coastal Hospice at the Lake at Deer's Head Hospital in Salisbury, volunteering there almost every Thursday evening. He spends his time with patients and their families plus helps staff with inventory and other administrative duties.

Coastal Hospice volunteer Ellen Lowe was surprised with her Jefferson Award at the church that nominated her, Asbury United Methodist in Sharptown, Md., where she works with children.

"I think a lot of people knew this that I didn't know," Lowe said after being told she was an award winner. "Thank you so much. It's an honor and a privilege."

Lowe has been a regular patient care volunteer at Coastal Hospice since 2005, going into patients' homes to help with whatever they or their family need. She dresses like an elf to participate in Coastal Hospice's annual Santa Run and volunteers at the hospice's summer grief support camp for children, Camp Safe Harbor at Salisbury University.

"I love to work with the children," Lowe said. "I know that it is important to be a good role model, and I know that I want for them what they might not even know they want."

The Jefferson Awards Foundation was created by the American Institute for Public Service that gives awards at both national and local levels. Local Jefferson Award winners are ordinary people who do extraordinary things without expectation of recognition.

Davis believes hospice is "taking care of your own"

The death of his grandmother inspired Elmer Davis, M.Div., to become a hospice chaplain.

"My grandmother, Odella Newton, was in Coastal Hospice's care," Davis said. "Before she passed, she told me I should do something for them because they were so kind to her."

Davis is a grief support counselor at

Coastal Hospice, helping those who have lost a loved one deal with their grief. "I believe God has called me to do this task," Davis said.

Part of the mission of Coastal Hospice is to continue to support the family after a loved one passes. The team of counselors makes phone calls to families, provides individual counseling, and runs support groups that meet across the four Lower Shore counties.

"What drew me to grief support was I understood the emotional ups and downs," Davis said. "In grief support, you bring back life to people who think the light has gone out. You bring them back to good memories, good days. You help them through the holidays. You help them validate their feelings about their loved ones."

Grief support counseling at Coastal Hospice is not about religion or faith, Davis points out. "We generally don't talk about our faith," he said. "We talk about processing the grief and give them the tools to do that. A lot of people just need the space to talk freely."

Davis, who was born and raised in Salisbury, attended James M. Bennett High School, Wor-Wic Community College and Wilmington University before earning his Masters Degree in Divinity from Howard University in 2005. He was a lieutenant with the Salisbury police for 22 years, dealing with crisis situations. A United Methodist Conference pastor, Davis has been married for 28 years to Tyronna Davis, with two children and two grandchildren.

Davis will begin running the grief support group meetings in Dorchester County. Anyone in the community who is experiencing grief is welcome to attend the free gatherings, not just families of hospice patients.

"Being in Dorchester, I'll be the grief support counselor, meeting individuals where they are, helping them through the grieving process with the support of others who are grieving at the same time."

Davis encourages the African-American community to use the services of Coastal Hospice, to make sure their loved ones receive the most advanced care. "In the African-America community, we tend to take care of our own families. But to me, taking care of your own means making sure they get the best care. That's hospice."

Davis said his own family was influenced to become hospice supporters by the care his grandmother received. "I watched and the whole family watched my grandmother's care," Davis said. "That really led me to do what my grandmother asked me."
