

Understanding Bequest Terminology

Specific Bequest:

The donor designates exactly what and how much to bequeath to Coastal Hospice.

Residual Bequest:

The donor expresses their gift as a percent of their total estate or residual estate: the portion of the one's estate that remains after debts, taxes, expenses and designations to individuals are paid out of the estate.

Contingent Bequest:

A contingent bequest provides for family and friends and will benefit Coastal Hospice only if the named beneficiaries predecease the writer of the will.
