

At Stansell House, each patient's circumstance is evaluated on an individual basis.

Eligibility includes, but is not limited to, a patient who:

- Is eligible for and has elected the hospice benefit
- Has progressive functional decline that makes home an unsafe place
- Has low-complexity care needs
- Does not "wander"

Admissions are accepted Monday through Friday and the room and board charges are assessed daily.

Patients with dementia must be at the "FAST D" status. Please ask us for more information.

Should a resident of Stansell House revoke the hospice benefit or have a prognosis that extends beyond hospice eligibility, our staff will assist the patient (or family) with finding alternative care arrangements.
